

PCI DSS 4.0: CERTIFICATE OF VALIDATION - 09-Feb-2024

Dara Security is pleased to provide this Certificate of Validation regarding the PCI Assessment and Accreditation for 365 Retail Markets, a Level 1 Merchant located at 1743 Maplelawn Troy MI 48084. Based upon the validation effort, Dara Security has determined that 365 Retail Markets is COMPLIANT with the PCI DSS 4.0 regarding their service offering for which 365 Retail Markets is the merchant of record.

Documentation review, preliminary interviews, and technical & physical inspections were completed from December 2023 – February 2024. Dara Security, a certified QSA, conducted this audit pursuant to PCI DSS v4.0requirements, standards and guidelines and in accordance with PCI DSS Security Audit Procedures v4.0 and generated the PCI DSS Report of Compliance on 09-Feb-2024.

The scope of the assessment included all components of 365 Retail Markets infrastructure, applications, systems, Internet access points and processing connections that are involved in the processing, transmitting and/or storing of payment card data regarding their Self-Service Stand Along Kiosk, Attended and unattended food service terminals and vending machines services. In addition, the assessment included all process, management, and data centers utilized by 365 Retail Markets. Review areas included: Policy and Procedures; Data Flow Analysis; System Inventory and Documentation; Physical/Environmental Security; Personnel and IT Staff Training and Awareness; Internal Vulnerability Assessment; Host/Network Diagnostic; Access Control; Data Storage; Wireless Network Analysis; Testing of Deployed Security Measures; and Monitoring/Response Assessment.

Dara Security reviewed results of 365 Retail Markets' most recent quarterly scans, completed by a certified ASV vendor (Tenable) to confirm they covered all externally accessible (Internet-facing) IP addresses within the scope of the PCI DSS review and that the results of these scans were passing. Reviews of these security scans indicate that 365 Retail Markets is compliant with the PCI ASV Scan validation requirements.

All requirements in the Report on Compliance are marked "in place", thereby 365 Retail Markets has demonstrated full compliance with the PCI Data Security Standard v4.0.
